DATA PROTECTION INFORMATION FOR DATA SUBJECTS

EXPER NEWSLETTER

Consulta Europa, the partner in charge of the EXPER newsletter, will process your data in accordance with the principle of fair and legitimate processing, only where necessary, using paper and electronic means, and adopting adequate security measures, only for the purpose of sending you the EXPER newsletter. The United Nations Personal Data Protection and Privacy Principles (“the UN Principles”) set out a basic framework for the processing of personal data by, or on behalf of, the United Nations System Organizations in carrying out their mandated activities. The UN Principles include the principle of transparency, which is to provide data subjects with detailed information on the processing of their personal data. By subscribing to the EXPER newsletter, you will send us your e-mail address, and we wish to inform you beforehand how it will be used. Your data will be processed by duly authorized UNESCO Staff members and personnel and will not be used for any other possible purposes. You may, at any time, request access to your data to verify it, and to request rectification and/or deletion of your data. Full information is provided below.

WHAT DATA WILL BE COLLECTED?

Only your e-mail.

WHAT WILL HAPPEN WITH MY DATA?

Your personal data will only be processed for the purpose of sending you the EXPER biannual newsletters, including main results of the EXPER project.





WHAT IS THE LEGAL BASIS FOR THE PROCESSING?

The legal basis for the processing of your personal data is your express consent, as foreseen by art. 6, par. 1, lett. a) of the GDPR.

WHO WILL HAVE ACCESS TO MY DATA?

Beside CONSULTA EUROPA, some other subjects will have access to your personal data, insofar as it is needed for the EXPER project. This will happen in full compliance with applicable laws and regulations.

These subjects include:

-  Technology providers (i.e. hosting service providers, Wordpress)
-  Competent authorities in charge of monitoring the project (i.e. the European Commission).

Other EXPER partners will not receive your personal data, unless they need to be involved in the management of the EXPER newsletter.

WILL MY DATA BE EXPORTED OUTSIDE THE EU?



No, your personal data will not be transferred outside the European Union, nor to international organisations.


HOW LONG WILL MY PERSONAL DATA BE KEPT?

Your personal data will be kept by CONSULTA EUROPA until you decide to unsubscribe from the newsletter. In case you maintain your subscription active for the whole duration of the project. In any case, your data will be stored for no longer than necessary in consideration of the purposes for which they have been processed.

CAN I REQUEST DELETION OF MY DATA?

As data subject, you may:

-  request access to and rectification or erasure of personal data;
-  object to processing;

 withdraw consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

You may also unsubscribe from the newsletter at any time by clicking on the link at the bottom of the email. If you have unsubscribed by clicking on the unsubscribe link, your data will be deleted at WordPress.

AM I OBLIGED TO PROVIDE MY PERSONAL DATA? CAN I REFUSE?

Providing the requested personal data is absolute voluntary but necessary to subscribe to the EXPER newsletter. If you fail to provide the required data, it will be impossible for you to receive the newsletter.

AUTOMATED DECISION-MAKING

No automated decision will be made on the basis of your personal data collected for the EXPER project.

Your data will not be used for profiling purposes.
